"Other organized bodies" shall be interpreted to mean organized bodies that have become popularly identified with a symbol, such as MIT (Massachusetts Institute of Technology), GM (General Motors), GMAC (General Motors Acceptance Corp.), etc. (See "List of Abbreviations.") Symbols, when they appear in copy, may be used for acts of Congress. Example: ARA (Area Redevelopment Act). VFW NLRB TVA AFL-CIO ARC ASTM"

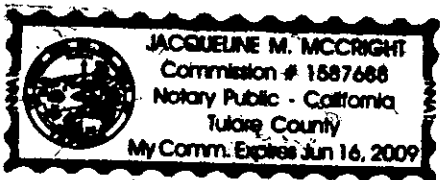
